Occupational health & safety is a major issue for any organization in the world. Be it large, small, private, state-owned, local or multinational, a business must take care of its people.

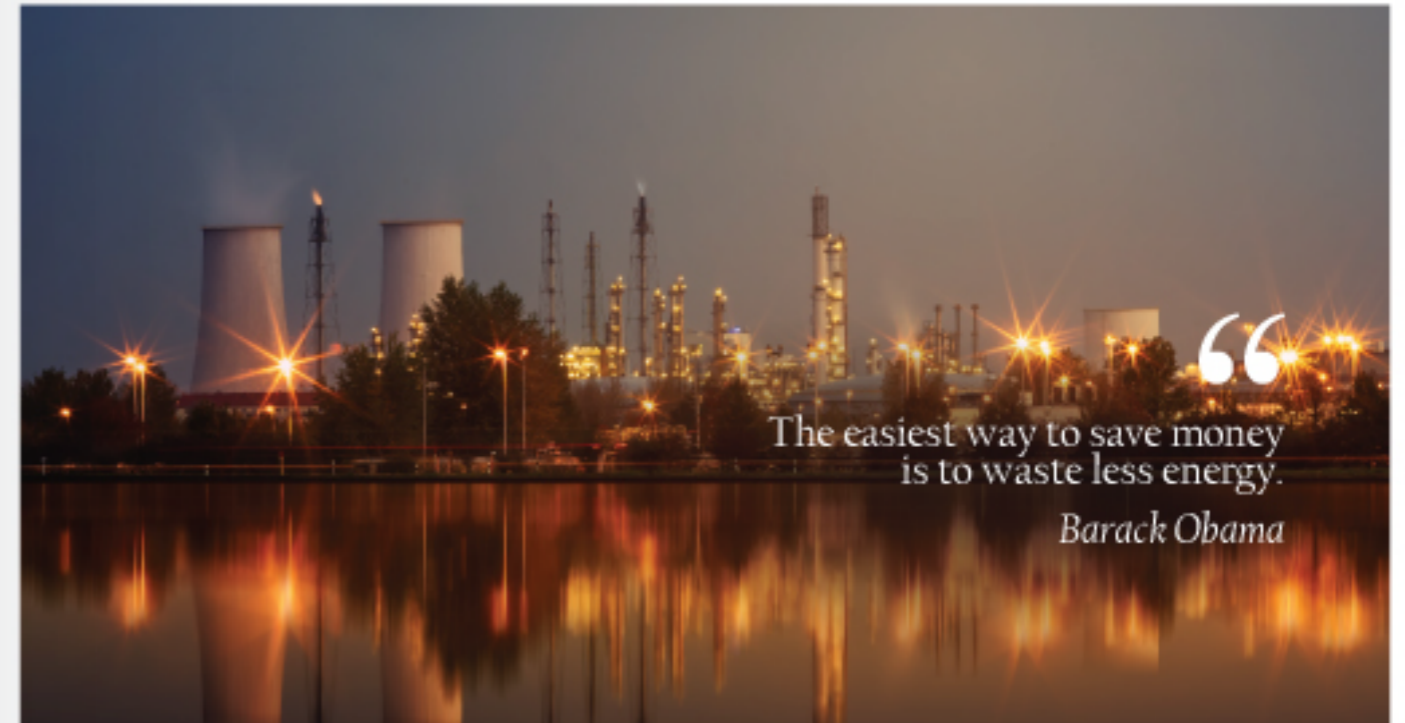

ISO / IEC 27001 Information Security

ISO/IEC 27001 defines the requirements for an Information Security Management System, including the controls meant to protect the confidentiality, integrity and availability of information.

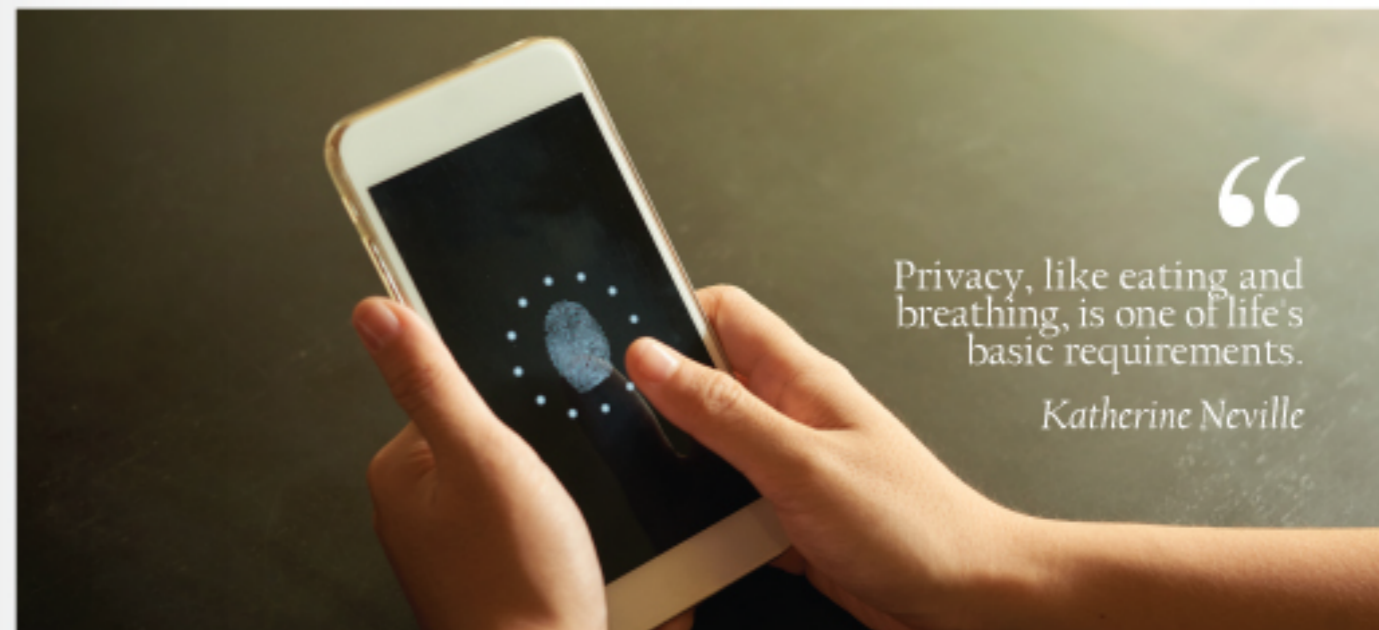
Certification to ISO/IEC 27001 provides assurance to customers, partners, authorities and other interested parties that the company's approach to protect information assets is effective.

ISO / IEC 27701 Privacy Information Management

Most, if not all organizations in the world, process personally identifiable information. The volume of data processed is increasing rapidly, while at the same time the requirements for privacy protection become more stringent.

ISO/IEC 27701 is an international standard that sets the requirements for a Privacy Information Management System. This standard is aligned with the GDPR (Regulation (EU) 2016/ 679) and other relevant privacy legislation.

Certification to ISO/IEC 27701 proves that the organization has adequate controls in place for processing personally identifiable information securely.

ISO 39001 Road Traffic Safety

ISO 39001 is an international standard, developed as part of an international project initiated by the United Nations and intended to change the current growth trend in road traffic accidents.

This standard is a collection of best practice for road traffic safety in an organization. It can be implemented by any company that interacts with the road infrastructure by either using it for transport purposes, designing, building or maintaining the road infrastructure or generating traffic to or from its locations.

Certification to ISO 39001 serves as evidence of the company's commitment to prevent road traffic accidents.

ISO 22301 Business Continuity Management

Business continuity is about identifying threats, evaluating their potential impacts, planning how to deal with disruptive incidents and how key business processes will continue to operate in case of a disaster.

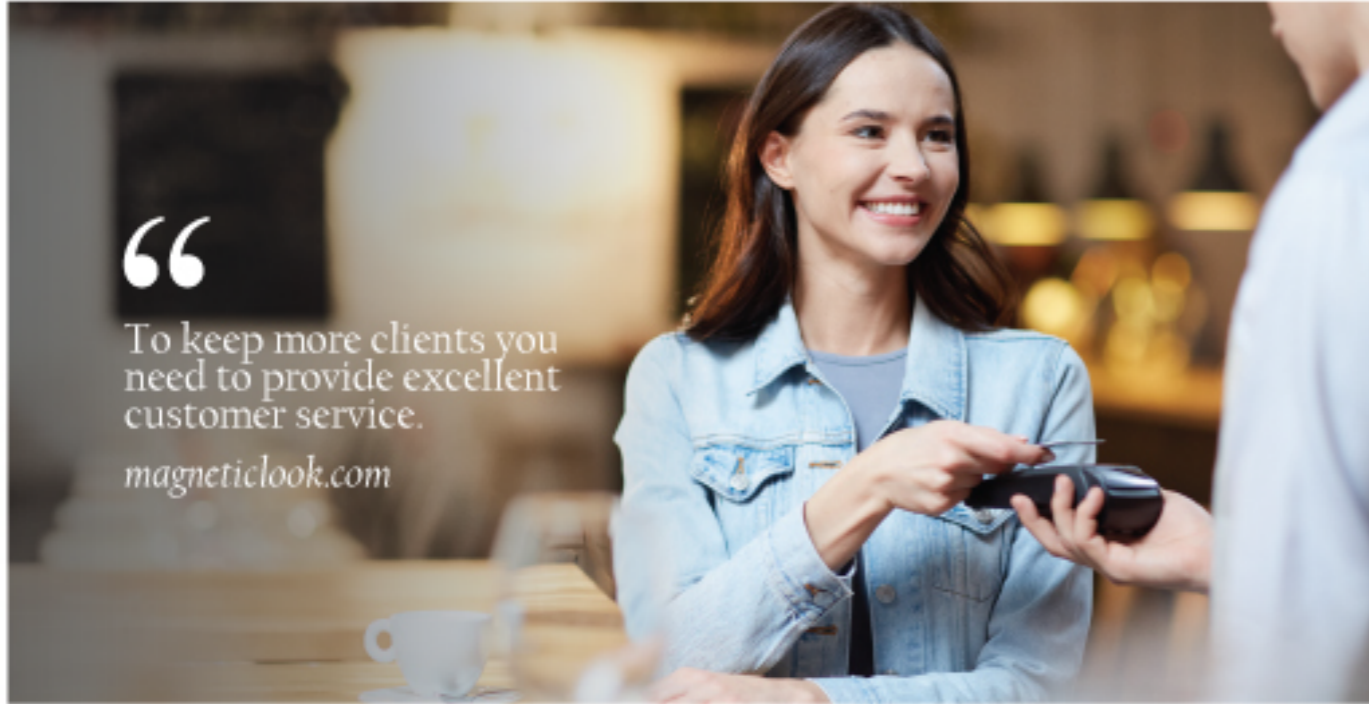

ISO / IEC 20000-1 Service Management

ISO/IEC 20000-1 defines the requirements for a Service Management System.

This standard is based on the best practice recommendations in ITIL (Information Technology Infrastructure Library) and is applicable to service providers regardless if the customers are external or they are part of the same organization.

Certification to ISO/IEC 20000-1 represents credible evidence of the service provider's customer focus and its capacity to deliver services that meet requirements.

ISO 37001 Anti-bribery Management
